How to Give

- Payroll Deduction:

(2) PTO donations are subject to all applicable payroll taxes and will be reported as wages on my IRS W-2 form in the calendar year in which the PTO hours are donated. (3) Any ongoing PTO donation election will be in effect until discontinuance is requested by me in writing.

PTO donations to Arroyo Grande Community Hospital Foundation are tax deductible to the fullest extent allowed by law. Arroyo Grande Community Hospital does not provide goods or services in consideration for contributions by payroll deduction.
